How does it work?

Your New York Documentary Experience is an add-on service for our custom/group tour clients.

The project begins with a quick meeting with your videographer before you begin your tour. This is your moment to direct, letting your shooter know what moments are most important for you or where you'd like the film to focus. You may also be asked some simple introductory questions on camera.

The videographer will accompany you on your tour to capture your experience cinéma vérité style. While we will make every attempt to record your tour without interruption, there may be moments when you are asked to pause for a shot, much like any tour group might pose for photos.

While you are moving from location to location, your videographer may ask questions or give you a moment to record your thoughts. Please feel free to say as much, or as little, as you like.

When you complete the tour, you will have another opportunity to record your feelings and experiences.

We will then take your footage and craft a unique retrospective of your day in New York. Your final film will be roughly 2 minutes in length, perfect for sharing online with friends and family. Delivery is approximately one week after your tour date.

Booking your documentary experience:

- Contact your tour company at least one week before your tour to confirm availability of a videographer for your date.
- Your tour booking agent will provide releases for each member of your group. Any attendees under the age of 18 must have parental approval before the tour date.
- Please provide your videographer with a preferred email for delivery.
- Your New York Documentary Experience is contingent on weather. Our cameras can't hold up to the rain.
